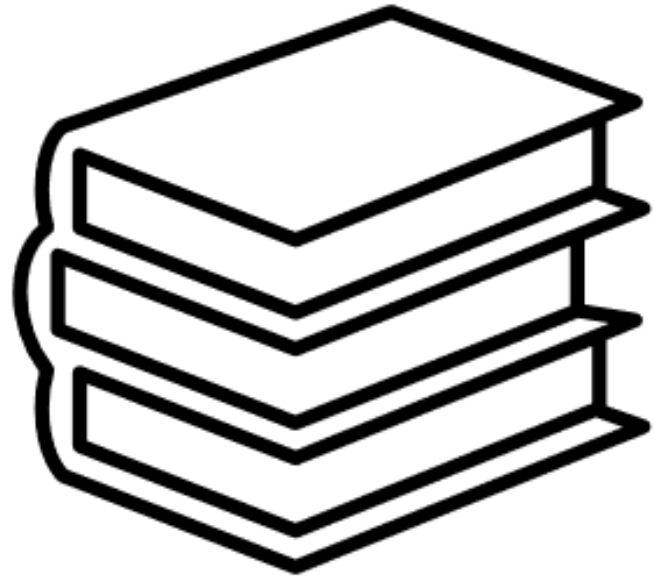

General Citation Notes

The 9 Core Elements

In MLA Style, facts common to most types of sources are called core elements. The table below shows the nine core elements.

1	Author.
2	Title of Source.
3	Title of Container,
4	Contributor,
5	Version,
6	Number,
7	Publisher,
8	Publication Date,
9	Location.

Supplemental Elements

In addition to the core elements, you may want or need to include other facts in a citation. For example, you may add the original publication date, or a translator's or other contributor's name, after the Title of Source element. You may need to add a date of access, the original publication facts, or other identifying information to the end of a citation.

Containers

- ◆ A container is any larger work containing the source, such as books, websites, anthologies, journals, databases, and DVDs.
- ◆ Containers can be nested. For a second container, add any relevant information for elements 3–9 and add it to your citation after the information for the first container.
- ◆ Some works, such as novels, are self-contained. In these cases, use only the top portion of the template, but omit the Title of Container element.
- ◆ This booklet includes a blank template you may use to practice creating works-cited entries.

Example MLA Template

The example below shows a completed MLA template for a citation for an article (“Charlotte Brontë”) in a scholarly journal (*Women’s Writing*) in a database (*EBSCOhost*). The corresponding works-cited entry appears at the bottom of this page.

- Image or Illustration Reproduced in the Paper but Not Cited in the Text** **Note:** If you reproduce an image or figure in your paper for illustrative purposes only, but do not cite it the text, a work-cited entry is not required in the works-cited list, but then, you must provide full bibliographical information in the caption. Example:

General Notes on Citations

What do I do when my source lacks some of the 9 core elements?

- ◆ Omit the **Author element** and begin with the Title of Source element if the author is unidentified, if the publisher is the author, or if the work is a collaborative work with many contributors, like a film.
- ◆ **Untitled works:** Use the first line of an untitled poem in place of a title. Place it within quotation marks, but do not alter the capitalization to title case. Works like Twitter tweets can be reproduced in full (if short) or part, within quotation marks, in place of a title. For other types of untitled works, give a brief description, in sentence case, without quotation marks.
- ◆ If **other information**, such as the date or publisher, is not available or not relevant, simply omit the element. In addition, the publisher of a periodical may be omitted from the work-cited entry. Provide a date of access at the end of your work-cited entry for undated online works.

The location element:

- ◆ For online works and works in a database, the location, in order of preference, is the digital object identifier (DOI), permalink, or URL. Very long URLs may be shortened.

Format:

- ◆ Each works-cited entry should be double spaced and aligned to the left margin. For entries that run more than one line, the second and any subsequent lines should be indented ½ inch. (Use the hanging indent setting in your word-processing program.)

Suitability of sources:

- ◆ **Always consider the credibility of sources** prior to using them. For example, publicly edited sites, like *Wikipedia*, may be suitable for a general understanding of a topic, but should not be used as direct source material.
